If serviced property is not within the City Limits of Bishopville, then it is understood and agreed that at any future time should any part of the property described above become contiguous to the City Limits of Bishopville, the owner will cause that property to be annexed. In this event, the City of Bishopville reserves the right to discontinue service until the above described is annexed. **CUSTOMER AGREEMENT/SERVICE CONTRACT**

If the **(City of Bishopville)** chooses to pursue debts owed by the applicant through the Setoff Debt Collection Act, the applicant agrees to pay all fees and costs incurred through the setoff process, including fees charged by the Department of Revenue, the South Carolina Association of Counties, the Municipal Association of South Carolina, and/or the **(City of Bishopville)**. If the **(City of Bishopville)** chooses to pursue debts in a manner other than setoff, the applicant agrees to pay the costs and fees associated with the selected manner as well.
